SECURITY WATER DISTRICT OUTDOOR WATERING PLAN



The Security Water District Board of Directors has approved an outdoor watering plan that includes progressive stages of watering restrictions. These outdoor watering restrictions will only be implemented when necessary to meet unusually high demand or when supplies are curtailed during drought or system emergencies.

Although the District has always encouraged the wise use of this precious resource, conservation has been more critical since a large portion of the District's water supply is not being used due to the contamination of the aquifer that feeds the wells. The District is currently constructing a new pipeline connection to Colorado Springs Utilities' system, which will be completed in mid-May. The new pipeline should allow the District to obtain enough water to meet peak demand for the next few years, until a groundwater treatment system is designed, thoroughly tested and constructed. Until the pipeline is completed, the District's water supply will be extremely limited. Consequently, although we are currently in Stage 1 Voluntary watering restriction (see below), the District is imploring customers to use water very sparingly until mid-May. Once the new pipeline is completed, the District will have a sufficient supply for the rest of the summer.

STAGE 1:

VOLUNTARY three day per week:

- Water no more than three times per week.
- Please follow this simple watering schedule. Homes/Businesses with addresses ending in <u>even</u> numbers may water on Monday, Wednesday and Saturday. Home/Businesses with addresses ending in <u>odd</u> numbers may water on Tuesday, Thursday and Sunday. All customers should avoid watering on Fridays.
- Trees, shrubs, flowers and gardens may be hand-watered any day with a positive shutoff nozzle.

Although the District is currently in Stage 1 Voluntary watering restrictions (see page 1), the District Board of Directors has adopted the following additional watering restriction stages to be implemented if necessary to meet unusually high demand or when supplies are curtailed during drought or system emergencies. If the more stringent Stage 2, 3 or 4 water restrictions are implemented, customers will be notified by mail, the District's website, social media and news media.

STAGE 2:

MANDATORY two day per week:

- Water no more than two times per week.
- Please follow this simple watering schedule. Homes/Businesses with addresses ending in <u>even</u> numbers may water on Wednesday and Saturday. Home/Businesses with addresses ending in <u>odd</u> numbers may water on Thursday and Sunday. All Customers should avoid watering on Monday, Tuesday, and Fridays.
- Trees, shrubs, flowers and gardens may be hand-watered any day with a positive shutoff nozzle.

STAGE 3:

MANDATORY no lawn irrigation:

- Watering of trees, shrubs, flowers and gardens ONLY (with a positive shut-off nozzle).
- Please follow this simple watering schedule. Homes/Businesses with addresses ending in <u>even</u> numbers may water on Saturday. Home/Businesses with addresses ending in <u>odd</u> numbers may water on Sunday. All Customers should avoid irrigating their lawns and only water trees, shrubs, flowers and gardens on your specified day.
